Out of town enforcement

The majority of the work we have done with taxis and private hire vehicles this week has been with the out of town trade, and the focus for the rest of the week for licenced vehicles will continue to be out of town drivers. We will continue checking for bookings and moving them on when parked without evidence of bookings. We do have officers coming in from other local authorities over the next two nights to assist with this.

We have been passing details regarding out of town drivers onto their local authorities and we have received feedback that action is being taken. We have also provided vehicle registrations to the police for vehicles suspected to be picking up illegally without displaying any signs to identify themselves as a private hire vehicle, and this will continue to be monitored.

If you do see anything and are able to record details, please do pass them to us and we can forward to the relevant authority or police.

Unlawful parking and obstruction

Whilst we are concentrating on out of town drivers and PHVs, we cannot ignore unlawful parking from our hackney trade. Rightly so, we must remain impartial and take a consistent approach. We simply cannot turn a blind eye to our HCDs parking on double yellow lines when we are asking out of town PHVs to move on for the same reason.

We ask drivers to not park on double yellow lines and restricted parking zones. We are aware that the area outside No.131 on the Promenade is a particular hot spot.

Please help us to free up our time to concentrate on out of town drivers by parking lawfully.

Display of badges and plates

Please ensure that, for all drivers and vehicles, your rear plate is firmly affixed whilst you are operating throughout Race Week.

You should also have two badges on display in the vehicle:

- One should be worn on your person.
- One should be affixed to the interior of the vehicle.

If you have lost either your plate or your badges please contact <u>licensing@cheltenham.gov.uk</u> and we can arrange to have one of these replaced. Correct display of both items is essential for public safety, so please ensure that you are ready for the busiest days of the Festival by having these items ready.
