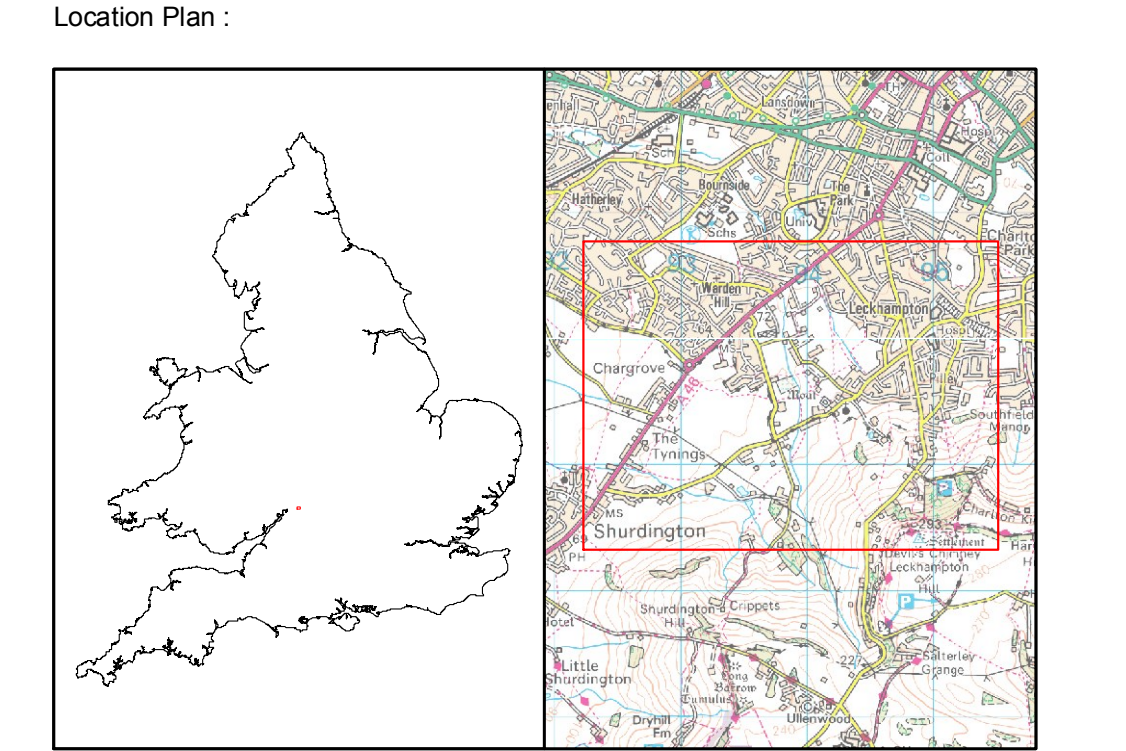

User Note :

This plan has been produced in accordance with Planning Policy Statement 25 - development and flood risk. Amendments will be required in future to account for information gathered subsequently e.g. changes in hydrological river response or observations following flood events. When in doubt the Environment Agency should be consulted.

It should be noted that certain locations not shown may be at risk of flooding from other sources (pipd drain systems, watermain etc.) and from other watercourses not shown in this study.

*Please note, surface water / pluvial flooding has not been mapped.
