Subject Matter

The Supplementary Planning Documents (SPDs) aim to expand upon policy or provide further detail to policies in Development Plan Documents (DPDs). The SPDs will form part of the Local Development Framework, and will be an important consideration in determining planning applications.

Civic Pride Area

The Civic Pride Urban Design Framework SPD is primarily focussed on Cheltenham town centre although it has relevance to the entire borough.

Central Conservation Area

The 16 SPDs listed above relate to parts of Cheltenham's Central Conservation Area. The Central Conservation Area has been split into 19 character areas in total.

The previous three SPDs relating to 1. Old Town; 2. Montpellier and 3. Bayshill character areas were adopted on 23rd February 2007. These remaining 16 SPDs complete coverage of the Central Conservation Area.

Date of Adoption

All the SPDs were adopted on 28th July 2008.

Grievances

Any person aggrieved by the Supplementary Planning Documents (SPDs) may apply to the High Court for permission to apply for judicial review of the decision to adopt the SPD. Any such application for leave must be made promptly and in any event not later than 3 months after the date on which the SPD was adopted.
