

## **Planning and Compulsory Purchase Act 2004: Adoption Statement**

### **Summary**

The Adoption Statement relating to the five Conservation Area Supplementary Planning Documents describes the subject matter; the area the documents apply to; the date of adoption and how to act if you have any grievances with the documents.

### **Title of Supplementary Planning Documents (SPDs)**

#### **Conservation Areas:**

- Prestbury Conservation Area (Character Appraisal &) Management Plan;
- St. Mary's (Charlton Kings) Conservation Area (Character Appraisal &) Management Plan;
- Cudnall Street (Charlton Kings) Conservation Area (Character Appraisal &) Management Plan;
- Bafford (Charlton Kings) Conservation Area (Character Appraisal &) Management Plan;
- The Poets (St. Mark's) Conservation Area (Character Appraisal &) Management Plan.

### **Subject Matter**

The Supplementary Planning Documents (SPDs) aim to expand upon policy or provide further detail to policies in Development Plan Documents (DPDs). The SPDs will form part of the Local Development Framework, and will be an important consideration in determining planning applications.

### **Area**

The five Conservation Areas are positioned in various parts of Cheltenham – Prestbury, St. Mark's and Charlton Kings. These remaining five SPDs complete coverage of all of Cheltenham's Conservation Areas.

### **Date of Adoption**

The five SPDs were adopted on 29<sup>th</sup> June 2009.

### **Grievances**

Any person aggrieved by the Supplementary Planning Documents (SPDs) may apply to the High Court for permission to apply for judicial review of the decision to adopt the SPD. Any such application for leave must be made promptly and in any event not later than 3 months after the date on which the SPD was adopted.
