1. THIS NOTICE is issued by the Local Planning Authority (LPA) because it appears that there has been a breach of planning control, within paragraph (a) of section 171A(1) of the above Act at the land described below. The Local Planning Authority considers that it is expedient to issue this Notice, having regard to the provisions of the development plan and to other material planning considerations. The Annex to this Notice and the enclosures to which it refers contain important additional information.

#### 2. THE LAND TO WHICH THE NOTICE RELATES:

Land at 12 Brizen Lane Cheltenham Gloucestershire GL53 0NG (As show edged red on the attached plan for identification purposes)

# 3. THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL

 Without planning permission the unauthorised change of use of the land from use as a residence to a mixed use for residential and business purposes including the storage of equipment and materials used in connection with a building contractors business.

#### 4. REASONS FOR ISSUING THIS NOTICE

• It appears to the Local Planning Authority that the above breach of planning control has occurred within the last ten years.

The unauthorised use is not an appropriate use of the land in the restricted residential cul-de-sac with adjacent residential properties in close proximity. It is considered that the unauthorised use is detrimental to the residential amenities of the local area and is contrary to national and local planning policies. In particular, Policy CP4 of the Local Plan which seeks to ensure development will not cause unacceptable harm to the amenity of adjoining land users including noise and disturbance.

The council do not consider that planning permission should be given because planning conditions could not overcome these objections.

#### 5. WHAT YOU ARE REQUIRED TO DO

 Stop using any part of the residential property and any part of the land for the storage of equipment and materials in connection with a building contractors business and permanently remove all equipment and materials from the land and property.

#### 6. TIME FOR COMPLIANCE

• 30 days after this Notice takes effect.
