

## ENVIRONMENTAL PROTECTION ACT 1990 CLEAN NEIGHBOURHOODS AND ENVIRONMENT ACT 2005 Section 94B Free Distribution of Printed Matter Schedule 3A Distribution of Printed Matter on Designated Land

Notice is hereby given that Cheltenham Borough Council ("the council") proposes by virtue of Section 94B and Schedule 3A, paragraph 2 of the Environmental Protection Act 1990 to designate certain places and streets where the distribution of free printed matter is prohibited without the consent of the council. The places and streets it proposes to designate are as follows:

Bath Road, Bath Street, Calderwood Court, Cambray Place, Chapel Walk, Chester Walk, Church Street, Clarence Parade, Clarence Street, County Court Road, Crescent Place, Crescent Terrace, Glensanda Court, High Street, Imperial Lane, Imperial Square, Imperial Circus, Lansdown Road, Montpellier Drive, Montpellier Parade, Montpellier Spa Road, Montpellier Spa Road, Montpellier Street, Montpellier Terrace, Montpellier Walk, Oriel Road, Ormond Place, Parabola Road, Promenade, Regent Street, Rodney Road, Royal Well Place, Royal Well Road, Royal Crescent, St Georges Place, St Mary's Chruch yard, Trafalgar Street, Albert Drive, Albert Road, Albemarle Gate, Albion Place, Albion Street, Albion Walk, Anlaby Court, Baynham Way, Bennington Street, Central Cross Drive, Clarence Square, Clarence Road, Cleevelands Drive, East Approach Drive, Evesham Road, Fairview Road, Henrietta Street, Hill Court Road, Lexington Square, New Barn Lane, North Place, North Street , Northfield Passage, Northfield Terrace, Marston Road, Monson Avenue, Oxford Passage, Pittville Lawn, Pittville Street, Pittville Park, Portland Street, Prestbury Road, Rose & Crown Passage, St Margarets Road, St Margarets Parade, Swindon Lane, The Gardens, Trinity Lane, Wallnut Close, Warwich Place, Wellington Lane, Wellington Road, West Approach Drive, West Drive, Winchcombe Street, unadopted alley between County Court Road and Promenade, unadopted alley between Rodney Road & Bath Street, unadopted alleyways to and through St Mary's church yard, Vittoria Walk, Wellington Street, Well Walk, all public car parks, green spaces & parks (within the designated area), Royal Well bus station.

The council proposes to adopt the provisions by 14 November 2016. The restrictions do not apply to the distribution of free printed matter by charity, by or on behalf of a political organisation or for the purpose of a religion or belief (Section 94B and Schedule 3A, paragraph 1(4) of The 1990 Act).

The Act should be consulted for full details.
