Schedule of Urgent Works

The following schedule identifies the urgent works required to be carried out in order to prevent further deterioration and damage to the fabric of the listed building.

Carefully remove all loose, cracked, unkeyed, and perished render on the front elevation and the side (gable) elevation including the parapet walls with due regard being given to the protection of the Banksy mural.

Key all exposed brickwork, prepare and re-render where the loose, cracked, unkeyed and perished render has been removed, or fallen off the building, to match existing flush with the adjacent surfaces.

Leave the whole sound and weatherproof upon completion.
