

**The Cheltenham Borough Council (Reorganisation of Community Governance)
(Charlton Kings Parish) Order 2018**

Coming into force in accordance with article 1(2)

The Cheltenham Borough Council ("the Council"), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 ("the 2007 Act"), has undertaken a community governance review and made recommendations dated 11th December 2017:

The Council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The Council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section:

The Council makes the following Order in exercise of the powers conferred by sections 86 and 240(10) of the 2007 Act.

Citation and commencement

1.-(1) This Order may be cited as the Cheltenham Borough Council (Reorganisation of Community Governance) (Charlton Kings Parish) Order 2018.

(2) Subject to paragraphs (3) and (4) below, this Order comes into force on 1st April 2018.

(3) Article 4 shall come into force on the ordinary day of elections of councillors in 2018

(4) For the purposes of:

(a) this article,

(b) proceedings preliminary or relating to the election of Parish Councillors for the parish of Charlton Kings, to be held on the Ordinary Day of Election of Councillors in 2018

this Order shall come into force the day after that on which it is made.

Interpretation

2. In this Order-

"Borough" means the Borough of Cheltenham Borough Council;

"Maps" means the maps marked "Map referred to in the Cheltenham Borough Council (Reorganisation of Community Governance) (Charlton Kings) Order 2018 – Map 1" to "Map referred to in the Cheltenham Borough Council (Reorganisation of

Community Governance) (Charlton Kings) Order 2018 – Map 4” inclusive and deposited in accordance with section 96(4) of the 2007 Act: and any reference to a numbered sheet is a reference to the sheet of the map which bears that number;

“Ordinary Day of Election of Councillors” has the meaning given by section 37 of the Representation of the People Act 1983; and

“Registration Officer” means an officer appointed for the purpose of, and in accordance with, section 8 of the Representation of the People Act 1983.

Effect of Order

3. This Order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provision of this Order

Alteration of parish areas and the areas of parish wards

4. (1) Each area designated by a number on the Map and specified in column (1) of the Schedule shall cease to be part of an unparished area and shall become part of the Parish of Charlton Kings and the Ward specified in relation to that area in columns (4) and (5) of the Schedule.

(2) The West Ward shall have two additional Parish Councillors

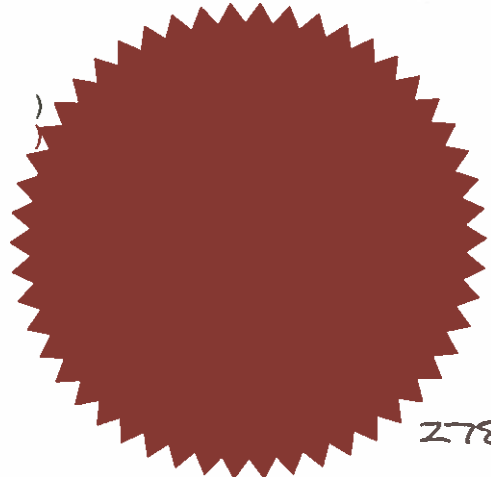
Electoral register

5. The Registration Officer for the Borough shall make such rearrangement of, or adaption of, the register of local government electors as may be necessary for the purpose of, and in consequence of, this Order.

Order date

6. 1st April 2018 is the order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.

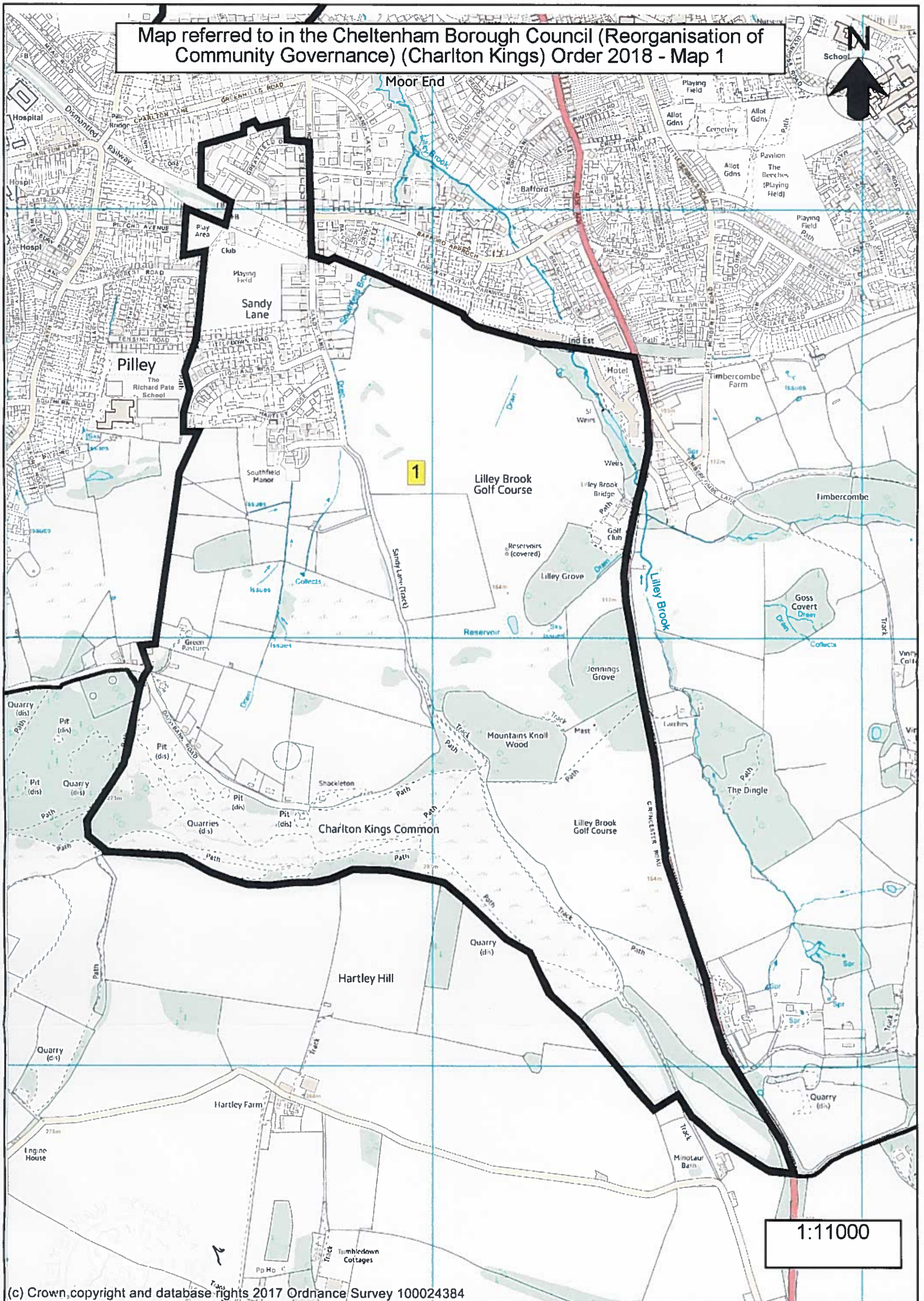

Map referred to in the Cheltenham Borough Council (Reorganisation of Community Governance) (Charlton Kings) Order 2018 - Map 1

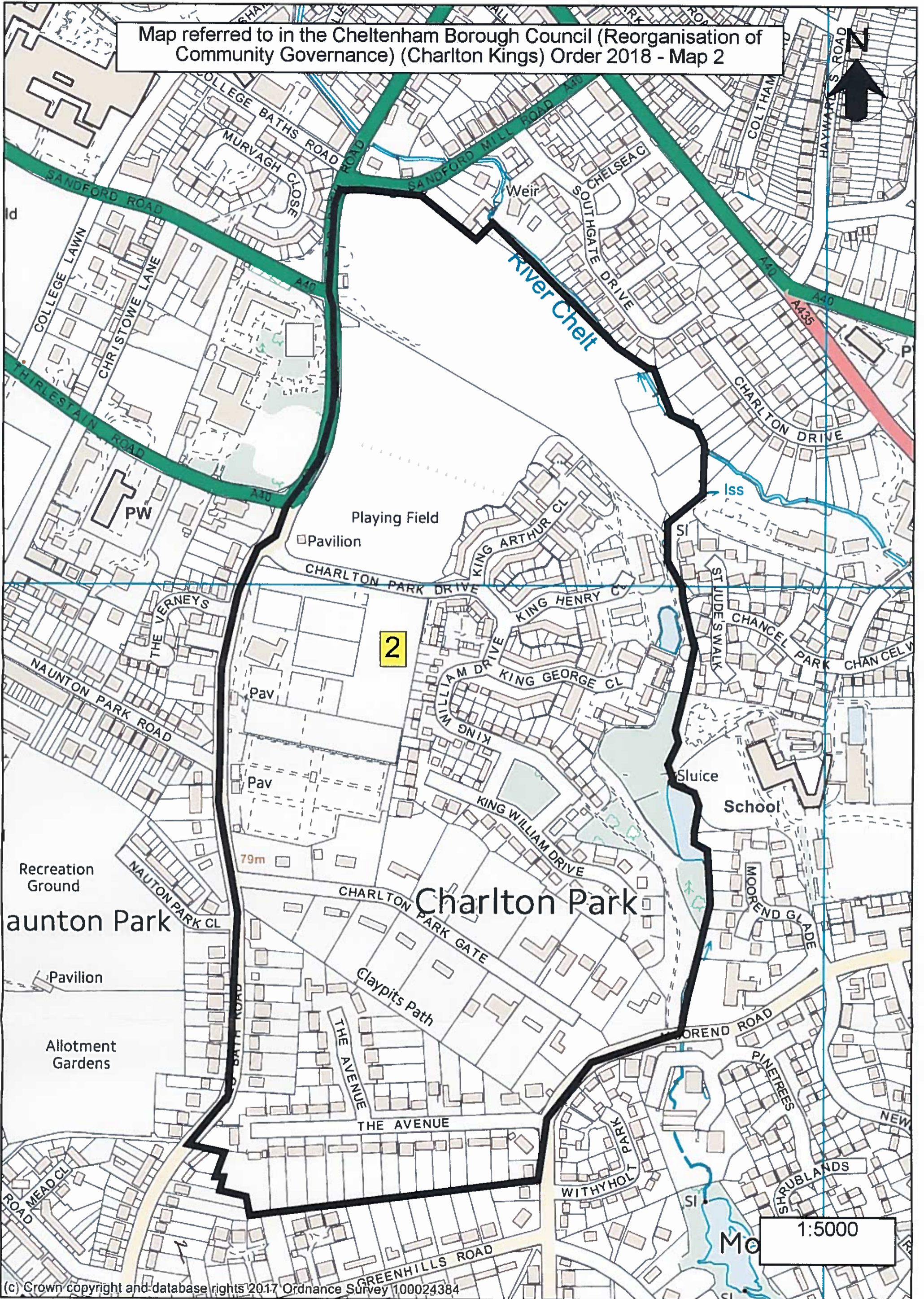

Map referred to in the Cheltenham Borough Council (Reorganisation of Community Governance) (Charlton Kings) Order 2018 - Map 2



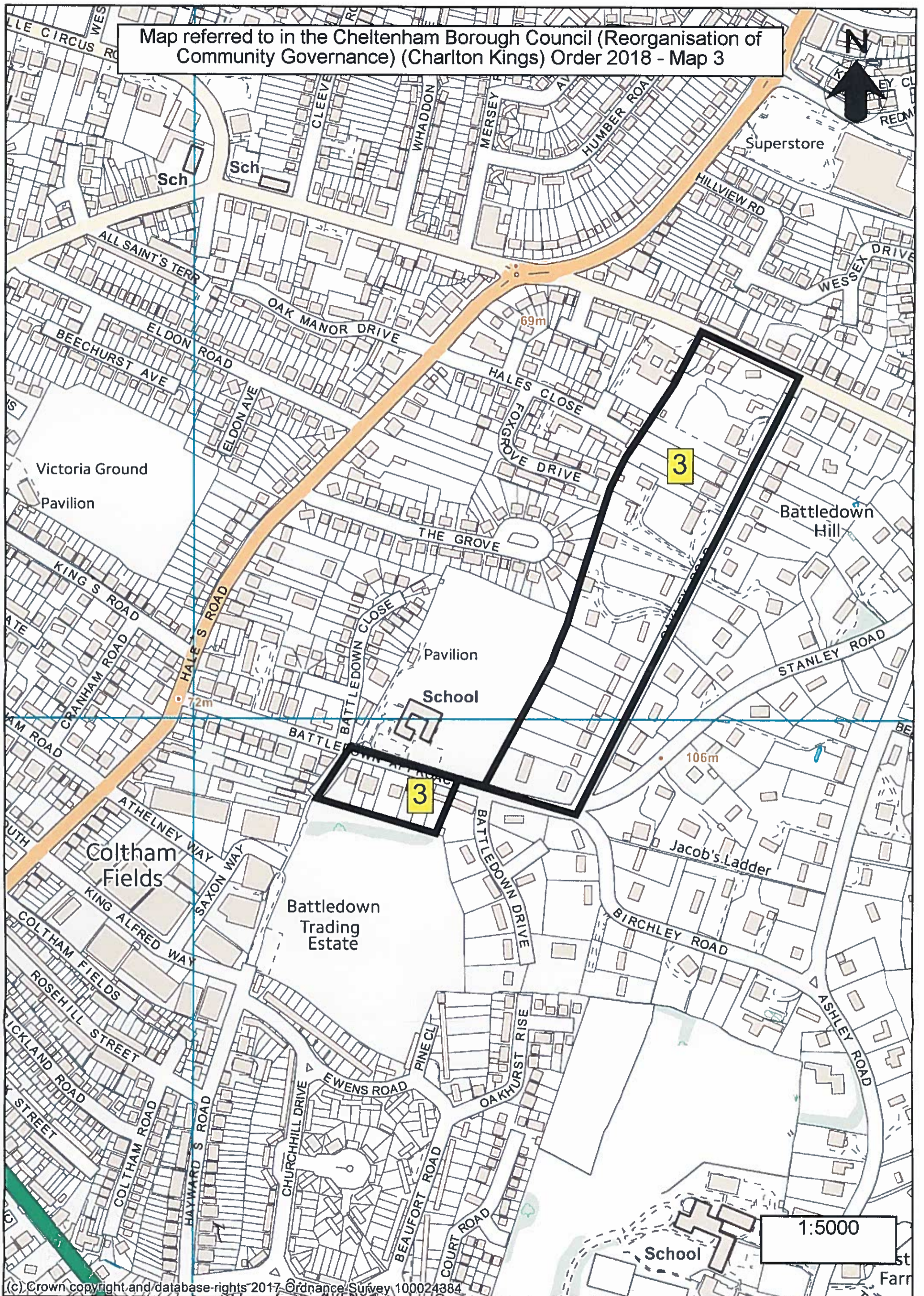

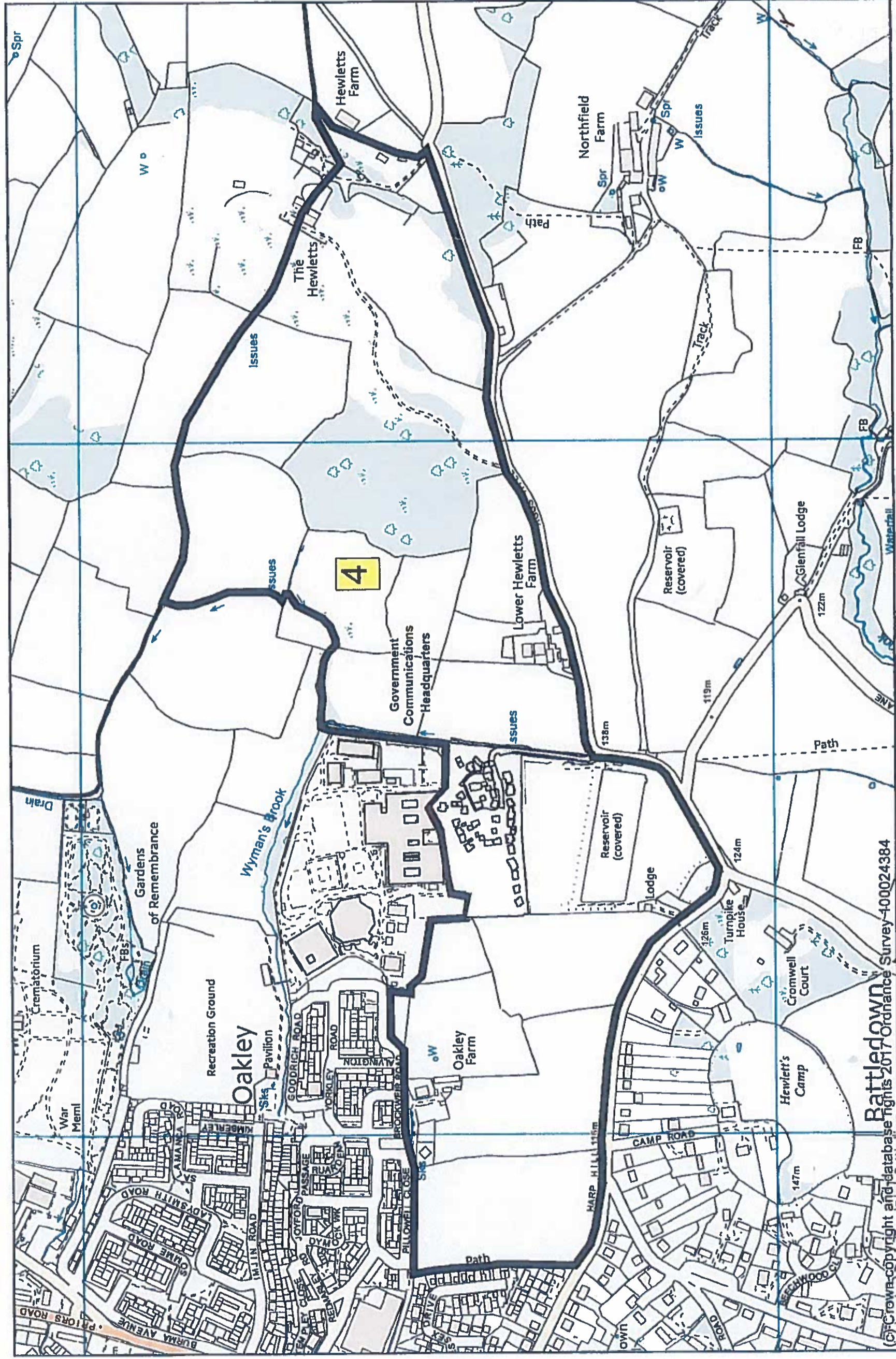
