Condition 5 - Notwithstanding the provisions of the Town and Country Planning (General Permitted Development) Order 1995 (or any Order revoking and/or reenacting that order) the first floor window facing 4 Corfe Close shall be glazed with obscure glass and shall incorporate a restricted opening mechanism, details of which shall be submitted to and approved in writing by the Local Planning Authority prior to the commencement of development. The window shall be installed in accordance with the details so approved and shall be maintained as such thereafter. Reason: To safeguard the amenities of the adjoining properties in accordance with Local Plan Policy CP4 relating to safe and sustainable living.

- Within 1 month from the LPA confirming acceptability of the proposed restricted opening mechanism to have it installed as per the submission and inspected by a representative of the LPA.
