Joint Core Strategy Call for Sites for <u>Strategic Assessment of Land Availability</u> and <u>Brownfield Register</u>, covering Gloucester, Cheltenham and Tewkesbury

The Joint Core Strategy authorities carry out assessments of the suitability of land for a variety of uses including housing, employment and other non-residential uses, and Gypsies and Travellers. These help us to understand the amount and type of development we can deliver through our local plans. In order to inform these assessments we carry out a 'call for sites' on an annual basis and accept submissions all year round. Any site submitted will be considered for incorporation in the next stage of plan preparation. Furthermore, information submitted on this form will be assessed in regard to our statutory requirement to produce a register of brownfield sites that meet national criteria.

Please use this form to provide information on sites within Gloucester City, Cheltenham Borough and/or Tewkesbury Borough that you wish to suggest for future development. A form can be accepted without all details completed but the more information you provide, the easier it will be for us to understand and assess a site.

All submissions must be accompanied by **a map** showing the site boundaries. The map should be clearly legible and have an Ordnance Survey base. For each site that you wish to suggest you will need to submit a separate form and map. Please note that not all sites we receive will be considered appropriate to be included within future planning policy documents. This is particularly the case where a site is small or constrained by local issues such as flood risk. In considering whether or not to submit a site you may find it useful to refer to existing and future plans and the associated evidence base, for example: www.cheltenham.gov.uk/planningpolicy
